APPROVAL FROM SGX-ST ON EXTENSION OF TIME TO RELEASE FINANCIAL RESULTS FOR THE FULL YEAR ENDED 31 DECEMBER 2015

The Board of Directors (the “**Board**”) of United Food Holdings Limited (the “**Company**” or together with its subsidiaries, the “**Group**”) refers to the Company’s announcement on 29 February 2016.

The Board is pleased to announce that SGX-ST, has on 8 March 2016, advised that they have no objection to the Company’s application for extension of time to announce its full year results for the year ended 31 December 2015 to 31 March 2016.

The extension of time granted by SGX-ST is subject to the following:
